Earlier this month, I had the opportunity to meet with leaders of centralized hearing panels from 18 of the nearly 30 central panels in the country in Des Moines, Iowa, at the 2017 Central Panel Directors' Conference. The conference gives central panel directors the

opportunity to share successes and challenges and seek advice from others who are more closely situated to them than many others in their own states.

Every year I am fascinated by both the differences and the similarities between these agencies. For example, Georgia employs 11 ALJs, who wear robes, ride circuits, and rule from the bench on more than 3,700 cases per year per ALJ! South Dakota has two ALJs who each hear approximately 125 cases per year. Across the board, these agencies struggle with case management,

training and evaluation of ALJs, security concerns, and improving processes.

Illinois is considered the newest central panel in that the CMS Bureau hears cases for a number of agencies (and, in fact, none from within CMS). As such, Illinois was given an hour to present on our progress, ask questions, and seek input

# Chief ALJs to meet for the first time this month -

The Bureau continues to look for ways to improve administrative justice for all litigants in Illinois. One component of this endeavor is the compilation of data relating to hearings held, decisions rendered, and staffing levels. Under Executive Order 17-04, I will be gathering this data on a quarterly basis.

Executive Order 17-04 also tasks the Bureau with looking for opportunities for agencies to work better together, to share resources to accomplish efficiencies, and reduce redundancy of processes. To that end, on November 17, 2017, I will be meeting with the Chief ALJs from each agency in the State that has a hearings unit. For agencies that do not employ a Chief ALJ, the General Counsel will send a designee to this first of many meetings. Together, the Chiefs will discuss hearings types, process challenges, and other issues related to the important work of administrative justice.
