As we move into the summer, I am excited to share with you more details about the **8**TH ANNUAL **ILLINOIS ADMINISTRATIVE** LAW **CONFERENCE.** After a welcome and introduction by Governor's General Counsel **Dennis** Murashko, Illinois Supreme Court Justice Rita Garman will give the keynote address.

The day-long conference will also include sessions on evidence and cultural competence in the administrative law setting. A panel of practitioners who appear before a wide spectrum of administrative hearings units will share their likes and dislikes of courtroom practices and weigh in on the impact of ALJ conduct on their clients and their practice.

Cook County Circuit Court Associate Judge Mary Cay Marubio will share her experience moving from serving as an ALJ to serving on the bench. Malcolm Rich from the Chicago Appleseed Foundation for Justice will join me and Wisconsin Central Panel Director Brain Hayes on a panel discussing central panels in the U.S. and the Bureau's progress and future.

Finally, participants will have the opportunity to obtain an hour of professional responsibility credit when Ari Telisman from the ARDC joins the conference.

The conference will be held in-person at the JRTC and at a TBD Springfield location. As is tradition, there will be also be a networking event following the conference. Details to follow.
