As we are can see the end of summer just around the corner, I have exciting news to share! Today, August 2, 2017, Governor Rauner issued Executive Order 2017-04, which continues the operation of the Bureau of Administrative Hearings, expands the Bureau's reach to up

to twenty-five agencies, and continues the focus on improving customer service through increased

shared training, promoting resources, tracking and eliminating backlogs, technology implementing improve solutions. and administrative regulations governing hearings.

Governor Rauner pointed to successes achieved during the pilot period as the basis for continuing the Bureau's work. These successes include the demonstrated efficiencies of case sharing between IDOL and IDPH and IDOR, implementation of the ALJ Code of Professional Conduct, draft model hearings

rules to standardize regulations, among others.

Of course, these successes would have never come to fruition without the work and support of so many of you. The Bureau will continue to work to solve the problems
